

MINIMUM RECOMMENDATIONS FOR COMMERCIAL APPLICATIONS

To help compare various types of cushions, the Carpet Cushion Council has provided the following minimum recommendations for separate (non-attached) commercial carpet cushion for three levels of traffic. Any cushion type and grade certified as meeting these guidelines for cushion for being installed at a particular traffic level can be expected to perform satisfactorily at that level under normal conditions, when used with a carpet made for the same specified traffic conditions.
